In my career at the Guam Customs & Quarantine Agency, I have had many milestones that have raised the bar of officer conduct and the public's expectations of the Agency. I have chosen only a few as an example.

In 2006, I implemented the Merit Promotion program, promoting 47 customs agents throughout the ranks of the Agency.

In 2005, I coordinated a sting operation with U.S. Customs and Border Protection Agency from Boston, MA. (USA) to apprehend arms dealers who thought they were purchasing high-tech military devices to launch missiles. This operation was consummated on Guam Customs Borders.

In 2004, I established the first canine (K9) training program with support from the Australian Customs Service.

In 2001, I sought funding to fully arm the entire Agency of 174 agents who protect Guam's borders and succeeded. During that time, I established a weapons qualification standard to train officers on the use of weapons and deadly force.

In 1995, I was credited with the largest methamphetamine (ice) seizure, a street value of USD\$11 million, at the Guam International

Airport.

In 1994, I challenged the incoming Governor regarding the merit promotion system, after being removed from my position as Chief of Customs. I won my case and it is now considered a landmark case, because it has overturned many cases locally and in the mainland USA, preventing political harassment after a change in government leadership.

I also reorganized the customs inspection procedures at the Guam International Airport making the Agency passenger friendly.

In 1986 - I established the "Container, Freight, Satellite Stations" to ease the seaport traffic burden, as well as, the "En-route Inspection Program" allowing passengers and tour companies to disembark upon clearance.

In 1982 - considering the political implication of the island, I was not deterred when a prominent political family member was arrested under my watch for trafficking the drug Heroin with a street value of USD\$80,000.

In 1975 - I dealt with the Vietnamese exodus and the heroin wars that followed.
