The XXXVIII Ordinary Congress of the International Handball Federation (IHF) will be held during the period from 5 to 8 November 2021.

Participation fee for Congress delegates

According to the IHF Statutes, each Member Federation may take part in the Congress with up to three delegates.

The participation fee for Congress delegates will be:

- **300.- Euros** (for accommodation in a single or double room per person and per night during the official Congress period, i.e. from 5 to 8 November 2021)

Including the following:

- accommodation
- breakfast
- lunch
- dinner
- 2 coffee breaks per Congress day
- 1 soft drink per meal per person
- simultaneous translation
- file including Congress papers
- social programme

In this context, we would like to inform you that the International Handball Federation will bear the costs for one representative of every Member Federation at the forthcoming Congress. It means that the IHF will cover the participation fee for one delegate per federation during the period from 5 November (arrival) to 8 November (departure). Extras and travelling costs have to be paid by the representatives or the federation concerned themselves.

The fee includes accommodation, breakfast, lunch and dinner with one soft drink per meal as well as participation in the social programme.

Election of candidates standing for IHF positions

Candidates standing for one of the positions mentioned in the list of IHF positions (available here) are kindly requested to complete and submit the corresponding application form, together with the required supporting documents, to the IHF Head Office (**by e-mail:** elections@ihf-online.info) before 6 August 2021. We would like to stress that candidates must fulfil all criteria according to Article 13.7 of the IHF Statutes as outlined in the application forms which should be completed by computer (avoiding handwriting).

In case of **first-time** candidatures (*Form 3* available here):

The application form must be duly signed and stamped by the National Federation concerned and signed by the candidate. In addition to the form, the following documents shall be submitted:

- Letter of nomination of the National Federation concerned
- Curriculum vitae of the candidate
- Passport photo of the candidate

In case of re-elections (Form 4 available here):

- 1. If nominated by the respective National Federation, the application form must be duly signed and stamped by the National Federation concerned and signed by the candidate. In addition to the form, the following documents shall be submitted:
 - Letter of nomination of the National Federation concerned
 - Curriculum vitae of the candidate
 - Passport photo of the candidate
- 2. If nominated by the IHF Council, the application form must be duly signed by the candidate. Please tick the box 'Yes' below 'Nominated and approved by IHF Council'. In addition to the form, the following documents shall be submitted:
 - Letter of nomination of the IHF Council
 - Curriculum vitae of the candidate
 - Passport photo of the candidate



Voting right

In compliance with Article 13.3.5 of the IHF Statutes, only those Member Federations (full members) that have met their financial obligations towards the IHF are entitled to vote at the Congress.

Non-active Member Federations are not entitled to vote at the Congress. At the start of the Congress, decisions in that respect shall be announced as a part of the roll call and determination of the number of votes. A Member Federation shall be considered non-active if all of the following three criteria apply:

- No handball activities in the country
- No handball stakeholders (organisations, coaches, referees, players) in the country
- No communication with the Continental Confederation concerned and the IHF

Associated IHF members and regional IHF members have the right to attend the IHF Congress without voting rights.



Congress languages

Translation into the following languages will be provided at the Congress: English - French - German - Spanish - Arabic - Russian.



Visa

If you require a visa to enter Turkey, we kindly ask you to upload a passport copy of each of your Congress participants to the registration form which shall be submitted **by 6 August 2021** at the latest.

The following four categories defined according to the information available on the official website of the Turkish Ministry of Foreign Affairs (http://www.mfa.gov.tr/visa-information-for-foreigners.en.mfa and http://www.mfa.gov.tr/turkish-representations.en.mfa) will apply (please check which category your delegates belong to and act accordingly):

- ♣ Delegates exempted from visa requirement (Category 1)
- Delegates requiring a visa and allowed to apply for an electronic visa on https://www.evisa.gov.tr/en/ (Category 2)
- ♣ Delegates requiring a visa to be applied for at the Turkish diplomatic representations in the delegates' own countries (Category 3)
- ♣ Delegates requiring a visa but whose countries don't have a Turkish diplomatic representation (Category 4)

Delegates of Category 4 shall receive their visas at the airport upon arrival to Turkey. It is of utmost importance that those delegates submit their passport copies to the IHF Head Office by the aforementioned deadline of <u>6 August 2021</u>. In case of failure to comply with the deadline, the issuance of the delegates' visas at the airport upon arrival to Turkey cannot be guaranteed.



COVID-19-related requirements

As the IHF's main objective is to organise the XXXVIII Ordinary IHF Congress in a healthy and safe environment for all parties involved, a COVID-19 Medical Precaution Plan will be

Further information about current entry requirements for Turkey will be communicated in due course. National law of the Republic of Turkey will be applicable.



Accreditation cards

All Congress participants will receive an accreditation card for the Congress.

Therefore you are kindly requested to upload a passport photo of each of your Congress participants to the registration form which shall be submitted **by 6 August 2021** at the latest. Please upload a digital photo in jpg format (150x150 pixels maximum). The photo should be 35mm wide x 45mm high with a light background.

IHF Statistics

The IHF Head Office is currently in the process of determining the statistical data of our individual Member Federations which, in accordance with the current IHF Regulations, shall be compiled in a general statistic survey.

In order to facilitate our task, we kindly ask you to complete and submit the online statistics form (*Form 5* available <u>here</u>) to the Head Office at your earliest convenience, however, <u>no later than 6 August 2021</u>.

In this context we should not fail to point out that apart from the IHF Statutes the International Olympic Committee, too, expect us to provide accurate figures about every Member Federation.

In case of failure to submit the statistics form by the aforementioned deadline, Article 11.4 of the IHF Regulations concerning Penalties and Fines shall apply.

IHF President's Development Award

According to Article 2 of the IHF Regulations for Awards, the IHF President's Development Award is granted to two IHF Member Federations every two years at the Ordinary Congress of the IHF. It is awarded for particular services to the development and spread of handball in the Member Federations' own countries and/or throughout the world. The IHF President's Development Award is granted to two applicants on two levels:

- 1. Handball developed countries
- 2. Emerging federations

If your federation would like to apply for the IHF President's Development Award, we kindly ask you to complete and submit the corresponding questionnaire, together with any supporting materials, to the IHF Head Office (**by e-mail: congress@ihf-online.info**) **by 6 August 2021**. The questionnaire (*Form 7* available here) should be completed by computer (avoiding handwriting).

Please attach the supporting materials to the questionnaire.



Hosting the XXXIX Ordinary IHF Congress 2023

The International Handball Federation would herewith like to put out to tender the 2023 Ordinary IHF Congress, which will be awarded during the 2021 Ordinary IHF Congress in Antalya.

If you are interested in organising the 2023 Ordinary IHF Congress, we kindly ask you to study thoroughly the bidding conditions for hosting the 2023 Ordinary IHF Congress (available here) and submit the completed event concept form (Form 8 available here) to the IHF Head Office (by e-mail: congress@ihf-online.info) no later than 6 August 2021, including detailed information about Congress venue, accommodation, transportation, meeting rooms' layout, proposal for the Congress date, etc. The form should be completed by computer (avoiding handwriting).
