

Conduct of Chad delegation

Request from **IHF Executive Committee** to IHF Ethics Commission dated 13 June 2024 to study the case related to the conduct of the delegation of Chad participating in the Men's IHF Trophy Zone 4 Africa held in Yaoundé, Cameroon, from 21 to 25 May 2024.

IHF Ethics Commission decision dated 2 October 2024:

1.- The conduct attributed to Chad delegation participating in the Men's IHF Trophy Africa – Zone 4 in CMR (Hervé Allambatnan, Secretary General of Chad Handball Federation; Masra Ismael, coach of the junior team; Eric Guingar, assistant coach of the junior team; Seid Adoum Moursal, coach of the youth team; Ahmat Dagal, assistant coach of the youth team, and Chad players: Junior Players: 1. Romiel Djimtoloum, 2. Kadre Ousmane, 3. Hermane Dangar, 4. Sylvain Djikoloum, 5. Narcisse Mbairamadji, 6. Armand Ngarmadji, 7. Abdoul Masra, 8. Henri Nadjingaï, and 9. Richard Malinguizal. Youth Players: 1. Olivier Mbaindiguim, 2. Mor Xavier Atepego, 3. Saleh Beri Hassane, 4. Narcisse Djehoikodji, 5. Abdoulaye Mahamat, 6. Ganita Isidore Ndot, 7. Omega B. Djessadjim, 8. Djimadoum Yanyanouba, and 9. Dernan Junior N.) represents a violation of the IHF Ethics Code, particularly its Article 5.

2.- The decision rendered by the International Handball Federation Ethics Commission, given the nature of the failure and the principle of proportionality of the sanction, is to impose on Chad delegation participating in the Men's IHF Trophy Africa – Zone 4 in CMR (Hervé Allambatnan, Secretary General of Chad Handball Federation; Masra Ismael, coach of the junior team; Eric Guingar, assistant coach of the junior team; Seid Adoum Moursal, coach of the youth team; Ahmat Dagal, assistant coach of the youth team, and Chad players: Junior Players: 1. Romiel Djimtoloum, 2. Kadre Ousmane, 3. Hermane Dangar, 4. Sylvain Djikoloum, 5. Narcisse Mbairamadji, 6. Armand Ngarmadji, 7. Abdoul Masra, 8. Henri Nadjingaï, and 9. Richard Malinguizal. Youth Players: 1. Olivier Mbaindiguim, 2. Mor Xavier Atepego, 3. Saleh Beri Hassane, 4. Narcisse Djehoikodji, 5. Abdoulaye Mahamat, 6. Ganita Isidore Ndot, 7. Omega B. Djessadjim, 8. Djimadoum Yanyanouba, and 9. Dernan Junior N.) **a one-year suspension from taking part in handball activities on all levels**. Said suspension will begin to count one day after this decision is notified. The above, in accordance with the provisions of Articles 5 and 8 of the IHF Ethics Code.

3.- The present decision shall be notified to the International Handball Federation Council, the African Handball Confederation, the Fédération Tchadienne de Handball and Chad delegation participating in the Men's IHF Trophy Africa – Zone 4 in CMR (Hervé Allambatnan, Secretary General of Chad Handball Federation; Masra Ismael, coach of the junior team; Eric Guingar, assistant coach of the junior team; Seid Adoum Moursal, coach of the youth team; Ahmat Dagal, assistant coach of the youth team, and Chad players: Junior Players: 1. Romiel Djimtoloum, 2. Kadre Ousmane, 3. Hermane Dangar, 4. Sylvain Djikoloum, 5. Narcisse Mbairamadji, 6. Armand Ngarmadji, 7. Abdoul Masra, 8. Henri Nadjingaï, and 9. Richard Malinguizal. Youth Players: 1. Olivier Mbaindiguim, 2. Mor Xavier Atepego, 3. Saleh Beri Hassane, 4. Narcisse Djehoikodji, 5. Abdoulaye Mahamat, 6. Ganita Isidore Ndot, 7. Omega B. Djessadjim, 8. Djimadoum Yanyanouba, and 9. Dernan Junior N.).

4.- This decision shall be enforceable immediately once notified.

Note: The decision was notified to the parties concerned on 9 October 2024 while the suspension started to count on the subsequent day, i.e. on 10 October 2024.
