Date

The 40th Ordinary Congress of the International Handball Federation (IHF) will be held during the period from 19 to 22 December 2025.



Accommodation / Congress Hotel

The Congress participants will be accommodated at:

The Congress as well as the different meetings on the fringes of the Congress will be held at the St. Regis New Capital's Convention Center (adjacent to the hotel).



Arrival / Departure

The Congress participants are kindly requested to arrive at and depart from Cairo International Airport (CAI). Transportation from the airport to the hotel (and vice versa) will be provided.

Participation fee for Congress delegates

According to the IHF Statutes, each Member Federation may take part in the Congress with up to three delegates.

The participation fee for Congress delegates will be:

- **USD 350.-** (for accommodation in a **single room** per person and per night during the official Congress period, i.e. from 19 to 22 December 2025)
- **USD 300.-** (for accommodation in a **double room** per person and per night during the official Congress period, i.e. from 19 to 22 December 2025)

Including the following:

- accommodation
- breakfast
- lunch
- dinner
- 2 coffee breaks per Congress day
- 1 soft drink per meal per person
- simultaneous translation
- file including Congress papers
- social programme

In this context, we would like to inform you that the International Handball Federation will bear the costs for one representative of every Member Federation at the forthcoming Congress. It means that the IHF will cover the participation fee for one delegate per federation during the period from 19 December (arrival) to 22 December (departure). Extras and travelling costs have to be paid by the representatives or the federation concerned themselves.

Registration

Closing date for registrations is <u>21 September 2025.</u> Please meet the registration deadline to guarantee your room reservation.

You are kindly requested to complete and submit the following online registration form:

- For Congress delegates (Form 1 available here)
- For Council members (Form 2 available here)

In the registration form, those federations entitled to vote also have the possibility to define which representative of your delegation should be the voting delegate. In case we don't receive any information from your federation in terms of the voting delegate by the above-mentioned deadline, we will assign the highest ranking delegate of your federation, who has been registered for the upcoming Congress, as voting delegate.



Election of candidates standing for IHF positions

Candidates standing for one of the positions mentioned in the list of IHF positions (available here) are kindly requested to complete and submit the corresponding application form, together with the required supporting documents, to the IHF Head Office (by e-mail: elections@ihf-online.info) before 21 September 2025. We would like to stress that candidates must fulfil all criteria according to Article 13.7 of the IHF Statutes as outlined in the application forms which should be completed by computer (avoiding handwriting).

In case of **first-time** candidatures (*Form 3* available here):

The application form must be duly signed and stamped by the National Federation concerned and signed by the candidate. In addition to the form, the following documents shall be submitted:

- Letter of nomination of the National Federation concerned
- Passport copy and passport photo of the candidate

In case of re-elections (Form 4 available here):

- 1. If nominated by the respective National Federation, the application form must be duly signed and stamped by the National Federation concerned and signed by the candidate. In addition to the form, the following documents shall be submitted:
 - Letter of nomination of the National Federation concerned
 - Passport copy and passport photo of the candidate
- 2. If nominated by the IHF Council, the application form must be duly signed by the candidate. Please tick the box 'Yes' below 'Nominated and approved by IHF Council'. In addition to the form, the following documents shall be submitted:
 - Letter of nomination of the IHF Council
 - Passport copy and passport photo of the candidate



Voting right

In compliance with Article 13.3.5 of the IHF Statutes, only those Member Federations (full members) that have met their financial obligations towards the IHF are entitled to vote at the Congress.

Non-active Member Federations are not entitled to vote at the Congress. At the start of the Congress, decisions in that respect shall be announced as a part of the roll call and determination of the number of votes. A Member Federation shall be considered non-active if all of the following three criteria apply:

- No handball activities in the country
- No handball stakeholders (organisations, coaches, referees, players) in the country
- No communication with the Continental Confederation concerned and the IHF

Associated IHF members and regional IHF members have the right to attend the IHF Congress without voting rights.



Voting system

In order to ensure that all technical and legal requirements are fulfilled, the entire Congress meeting will be attended by Lumi AGM UK Ltd (based in United Kingdom), who is providing a well-functioning and secure voting system, and by Cheeswrights Scrivener Notaries LLP (based in United Kingdom), who is supervising the voting process during the Congress. Both companies have been involved in the organisation of the 2021 and 2023 Ordinary IHF Congresses held virtually.

All representatives of the Member Federations (voting and non-voting delegates) will be asked to log into the Lumi voting platform during the Congress. Important instructions in this regard will be communicated to you in due course.

In order to give all of you the possibility to become familiar with the Lumi voting platform, two training sessions will be held well in advance (dates yet to be determined).



Congress languages

While English is the main language of the Congress, simultaneous translation into the following languages will be provided during the Congress: French, German, Spanish, Arabic, and Russian.



Visa

Each Congress participant who requires a visa to enter Egypt is kindly asked to upload a passport copy to the registration form which shall be submitted **by 21 September 2025** at the latest. In case of failure to comply with the deadline, the issuance of the delegates' visas prior to the Congress cannot be guaranteed.



Accreditation cards

All Congress participants will receive an accreditation card for the Congress.

Therefore, you are kindly requested to upload a passport photo of each of your Congress participants to the registration form which shall be submitted **by 21 September 2025** at the latest. Please upload a digital photo in jpg format (150x150 pixels maximum). The photo should be 35mm wide x 45mm high with a light background.

IHF Statistics

The IHF Head Office is currently in the process of determining the statistical data of our individual Member Federations which, in accordance with the current IHF Regulations, shall be compiled in a general statistic survey.

In case of failure to submit the statistics form by the aforementioned deadline, Article 11.4 of the IHF Regulations concerning Penalties and Fines shall apply.

IHF President's Development Award

According to Article 2 of the IHF Regulations for Awards, the IHF President's Development Award is granted to two IHF Member Federations every two years at the Ordinary Congress of the IHF. It is awarded for particular services to the development and spread of handball in the Member Federations' own countries and/or throughout the world. The IHF President's Development Award is granted to two applicants on two levels:

- 1. Handball developed countries
- 2. Emerging federations

If your federation would like to apply for the IHF President's Development Award, we kindly ask you to complete and submit the corresponding questionnaire, together with any supporting materials, to the IHF Head Office (**by e-mail: congress@ihf-online.info**) **by 21 September 2025**. The questionnaire (*Form 7* available here) should be completed by computer (avoiding handwriting).

Please attach the supporting materials to the questionnaire.



Hosting the 41st Ordinary IHF Congress 2027

The International Handball Federation would herewith like to put out to tender the 2027 Ordinary IHF Congress, which will be awarded during the 2025 Ordinary IHF Congress in Cairo.
