



## IHF – HANDBALL NEWS & RESULTS – TERMS AND CONDITIONS

Please read the following to learn more about the ways in which the IHF uses your information before you proceed with the use of the official IHF – Handball News & Results (hereinafter referred to as 'IHF News App').

### **1. Who are we?**

The IHF News App was created at the initiative of the International Handball Federation (IHF), which is based in Basel, Switzerland and is designed, developed and operated by Link Development, a company based in Cairo, Egypt.

### **2. What purpose does the IHF News App hold?**

The IHF News App is a mobile application to provide handball fans all around the world with information about activities within the handball community. Users can find news, statistics and media highlights of the championships and events of the International Handball Federation.

### **3. How do we use your information?**

The IHF is collecting information from you when you subscribe to our newsletter. The IHF also collects personal data when you create a user account on the IHF News App.

### **4. What kind of information are we collecting?**

If you create a user account, the IHF will ask you to provide your login information: email address, username, password and mobile number. The IHF will also ask you to provide personal info: first name, last name, country of residence, address and t-shirt size. This information will allow us to create and maintain your user account, identify you as one of our registered users and participate in online games.

### **5. Is your information shared with third parties?**

The IHF will only provide your information to third parties in the following circumstances: (1) We share certain user information with our affiliates and service providers who work with us to offer you this handball experience; (2) The IHF may share your information with authorities or third parties when we believe that we have a legal obligation to do so and (3) we may share your information with third parties when you have given us your prior authorisation to do so.

### **6. Does the IHF send emails requesting your information?**

Please note that the IHF does not and will not, at any time, request your credit card information, your account ID, login password or national identification numbers in a non-secure or unsolicited email or telephone communication. If you receive this kind of email, it could be an attempt to steal your identity.

## **7. Does this Privacy Policy work for third-party websites you can access via the IHF News App?**

If any part of the IHF News App links to other websites, those websites do not operate under this Privacy Policy. If you choose to visit an advertiser or click on another third-party link (example: social media websites), you will be directed to that third party's website which has its own privacy policy. Please note that the IHF does not exercise any control over third-party websites.

## **8. What are your rights regarding the information we collect?**

According to the GDPR (articles 13 to 23), you have the following rights:

- the right to be informed about our collection and use of information;
- the right of access to the information the IHF holds about you;
- the right to rectification if any information the IHF holds about you is inaccurate or incomplete;
- the right to be forgotten – i.e. the right to ask the IHF to delete any personal data;
- the right to restrict (i.e. prevent) the processing of your information;
- the right to data portability (obtaining a copy of your information to re-use with another service or organisation);
- the right to object to the IHF using Your information for particular purposes; and
- rights with respect to automated decision-making and profiling.

This Privacy Policy and the way the IHF uses your information are designed to uphold those rights.

## **9. How can you use those rights?**

In order to review, correct, update, or delete the data the IHF has collected from you, please contact us by email at [ihf.office@ihf.info](mailto:ihf.office@ihf.info) or with a written notification to Peter Merian-Strasse 23, P.O. Box, CH-4002 Basle, Switzerland.

The IHF may require you to provide verification of your identity. Any complaint can also be addressed to the Swiss Federal Data Protection and Information Commissioner (FDPIC) or the competent Information Commissioner in the EU (where applicable).

## **10. Which jurisdiction and which law are applicable?**

This Privacy Policy and all matters arising out of or related to this Privacy Policy shall be governed by the substantive laws of Switzerland, without regard to conflicts of laws and principles thereof.

Any controversy, claim or dispute between you and the IHF arising out of or relating to this Privacy Policy shall be subject to the exclusive jurisdiction of the competent Courts of the City of Basle, and each party hereby irrevocably consents to the jurisdiction and venue of such Court.

The International Handball Federation ('IHF', 'our') is pleased to provide you with its IHF – Handball News & Results (the 'IHF News App') subject to the following Terms of Use and any documents referred to herein ('Terms').

## **1. ACCEPTANCE OF TERMS**

- 1.1 By accessing the IHF News App, whether or not you become a registered user ('user', 'you', 'yourself', 'your'), you agree to be bound by these Terms, which you acknowledge to have read and understood.
- 1.2 The IHF reserves the right to change, modify or otherwise alter these Terms at any time. You must review these Terms in the 'Terms of Use' section on a regular basis to keep yourself informed of any changes.
- 1.3 By using the IHF News App, you agree that the posting of new or revised Terms on or within the IHF News App shall constitute adequate and constructive notice to you of any and all revisions and changes. Continued use of the IHF News App after any such changes or after explicitly accepting the new Terms upon logging into the IHF News App shall constitute your acceptance of such changes.

## **2. YOUR REGISTRATION OBLIGATIONS**

- 2.1 Certain areas of the IHF News App require registration ('**Restricted Areas**'). By registering, you acknowledge and certify that: (i) you are eligible for an account as set forth in these Terms; and (ii) the information you include as part of the registration process is accurate and not misleading. Accounts may only be obtained and used by: (i) individuals who are at least eighteen (18) years old or of legal age in their country of residence, if such age exceeds eighteen (18); (ii) those individuals whose registration has been authorised either by their parents or legal guardian, if they are below the legal age in their respective country of residence; or (iii) individuals with the right and authority to act on behalf of an organisation or entity for the purposes of accessing and using the IHF News App.
- 2.2 In respect of your use of these Restricted Areas, you hereby agree to: (i) provide true, accurate, current and complete information about yourself, as prompted by the registration form; and (ii) maintain and promptly update the registration data to keep it true, accurate, current and complete. If you provide, or the IHF has reasonable grounds to suspect that you have provided, any information that is untrue, inaccurate, not current or incomplete, or that the IHF otherwise reasonably considers that you have failed to comply with any provisions of these Terms, the IHF has the right to suspend or terminate your account and refuse you any and/or all current or future use of the IHF News App.

## **3. MEMBER ACCOUNT, PASSWORD AND SECURITY**

- 3.1 You will receive a password and a personal account upon completing a registration process (as described in sections 2.1 and 2.2). You are fully responsible for maintaining the confidentiality of the password and account, and for all activities that occur under your password and account.
- 3.2 You hereby agree to: (i) immediately notify the IHF of any unauthorised use of your password or account and any other breach of security; and (ii) ensure that you sign out of your account at the end of each session. The IHF cannot and will not be liable for any loss or damage arising from your failure to comply with this section.

#### **4. SUPERVISING CHILDREN**

The IHF is concerned about the safety and privacy of all its Users, particularly those not yet of legal age in their respective country of residence. For this reason, parents/guardians who wish to allow their children access to the IHF News App must review and accept these Terms and assist such children with the setting up of any relevant accounts, as well as supervise their access to the IHF News App. By allowing your child access to the IHF News App, you agree to be bound by these Terms, and acknowledge that he or she will be able to access all of the IHF News App, which may now or in the future include public and private communication tools, as well as other features that may not be appropriate for use by unsupervised children.

#### **5. CONTENT**

The IHF News App includes content: (i) provided by the IHF; (ii) that is uploaded, posted, submitted or otherwise transmitted by users of the IHF News App.

*(i) IHF content*

5.1 All IHF content is owned by, or licensed to the IHF. It may not be used, reproduced, distributed, transmitted, broadcast, displayed, sold, licensed or otherwise exploited for any other purposes than for accessing and using it on the IHF News App. For that sole and exclusive purpose, the IHF grants you a limited, revocable, non-exclusive license to access and use the IHF News App privately for non-commercial purposes, in accordance with these Terms.

*(ii) User Submissions*

5.2 You retain all rights in any user submission that you provide on the IHF News App. You shall be solely responsible for your own user submissions and the consequences of uploading them.

5.3 The IHF News App provides, in some cases, unfiltered access to user submissions. You hereby acknowledge and agree that the IHF only acts as a platform for such user submissions and that the IHF is not liable for such content posted on the IHF News App, whether arising under intellectual property laws, libel, privacy, obscenity, or otherwise. The IHF cannot, nor does it undertake any obligation, to control user submissions.

5.4 You insure that your user submissions: (i) shall not infringe any copyright, patent, trademark, trade secret, or other proprietary right or right of publicity or privacy; (ii) shall not violate any law or regulation; (iii) shall not be defamatory or trade libellous; (iv) shall not be obscene or contain pornography; (v) shall not include incomplete, false or inaccurate information about yourself or any information about any other individual; and (vi) shall not contain any viruses, Trojan horses, worms, time bombs, cancelbots or other computer programmes that are intended to damage, detrimentally interfere with, surreptitiously intercept or expropriate any system, data or personal information. You, in particular, insure that you have the written consent, release, and/or permission of each and every identifiable individual in any user submission to use their name or likeness.

5.5 You grant the IHF an irrevocable, worldwide, non-exclusive, royalty-free, perpetual, sub-licensable and transferable license to use, reproduce, distribute, prepare derivative works of, display and perform the user submissions in connection with the IHF News App.

5.6 You hereby acknowledge and agree that the IHF may, at its sole discretion, edit, remove or delete any user submission that you post or submit, as well as terminate your access to the IHF News App without notice if, in its opinion, such user submission does not comply with any provision of these Terms.

#### **6. TRADEMARK AND COPYRIGHT INFORMATION**

The IHF, the IHF logo, the emblems and mascots of IHF events and other IHF logos, IHF event marks and product and service names are trademarks and copyright material of the IHF. You agree not to display or use those information in any other manner without the IHF's prior written consent. Reproduction of any part of this mobile

application or its content for purposes other than personal use is strictly prohibited without written consent from the International Handball Federation. Such consent is also required in order to create hyperlinks to this site.

## **7. COPYRIGHTS AND COPYRIGHT AGENTS**

The IHF respects the intellectual property of others. If you believe that any of your intellectual property rights have been infringed on the IHF News App, please provide the IHF with the following information: name, last name, address, email address, type and extent of infringement (date, time, etc.) via email at [ihf.office@ihf.info](mailto:ihf.office@ihf.info).

## **8. MODIFICATIONS TO SERVICE**

The IHF reserves the right at any time to modify or discontinue, temporarily or permanently, the IHF News App and the user submissions with or without notice. You hereby agree that the IHF shall not be held liable for any modification, suspension or discontinuance of the IHF News App. Although the IHF will take reasonable care in ensuring that the IHF News App is up to date.

## **9. PRIVACY POLICY**

By using the IHF News App, you, or any person you allow to access and use your account, may provide the IHF with certain personal data, including the registration data and other information about you. By accessing or using the IHF News App, or submitting your personal information to the IHF News App, you agree to the IHF's use of such data in accordance with the IHF Privacy Policy of the IHF News App.

## **10. TERMINATION**

The IHF may, at its sole discretion and without liability to you, with or without cause, in particular if you do not comply with these Terms or without prior notice and at any time: (i) terminate your access (whether restricted or not) to the IHF News App, in whole or in part; and (ii) deactivate or delete any of your accounts and all related information and files in such accounts as well as your user submissions.

## **11. DISCLAIMERS**

- 11.1 If you access and use our IHF News App, you do so at your sole risk. The IHF expressly disclaims, and you waive, all warranties.
- 11.2 The IHF makes no warranties that: (i) the IHF News App will meet your requirements. (ii) the IHF News App will be uninterrupted, timely, secure, or error-free.
- 11.3 Downloading or obtaining any material through the use of the IHF News App shall be done at your own discretion and risk. You will be the sole responsible for any damage to your computer system or loss of data that results from downloading any such material.

## **12. INDEMNIFICATION**

You hereby agree to indemnify and hold the IHF and its subsidiaries and employees, harmless from any and all liabilities, losses, damages, claims, penalties, fines, costs and expenses, including, and without limitation, reasonable legal fees, that may arise in connection with: (i) your use of and access to the IHF News App; (ii) your failure to comply with any provision of the Terms.

## **13. LIMITATION OF LIABILITY**

You expressly acknowledge and agree that the IHF shall not be liable for any direct, indirect, incidental, special, consequential or exemplary damages, including, but not limited to, damages for loss of profits, goodwill, use, data or other intangible losses (even if the IHF has been advised of the possibility of such damages), resulting from the use of or the inability to use IHF News App.

#### **14. EXCLUSIONS AND LIMITATIONS**

Some jurisdictions do not allow the exclusion of certain warranties or the limitation or exclusion of liability for incidental or consequential damages. Accordingly, some of the above limitations under sections 12 and 13 may not apply to you.

#### **15. GENERAL INFORMATION**

- 15.1 These Terms constitute the entire agreement between you and the IHF in relation to their subject matter, superseding and extinguishing any prior agreements, arrangements, undertakings of any nature, between you and the IHF, whether oral or written in relation to such subject matter.
- 15.2 Any failure by the IHF to exercise or enforce any right or provision of the Terms shall not constitute a waiver of such right or provision.
- 15.3 If any provision of the Terms is found to be invalid, the parties nevertheless agree that the parties' intentions, as reflected in the provision, shall be given effect to the fullest extent practicable, and the other provisions of the Terms remain in full force and effect. The section titles in the Terms are for convenience only and have no legal or contractual effect.
- 15.4 The Terms and the relationship between you and the IHF shall be governed by the **substantive laws of Switzerland**. All disputes in connection with these Terms are to be resolved by the competent Courts of the City of Basle.
